**Form considerations:** treated or non-treated seeds or planting stock, use of pelleted seed, or use of bare root nursery stock or container plants. **Quality considerations:** germination rate of the seed; presence of weed seeds in the seed mix; shelf life and stability of the seeds; and disease and pest resistance. **Quantity considerations:** Not available in sufficiently large or small amounts given the scale of the operation.
